## 2023 PAY-FOR-PERFORMANCE/HEDIS® PERFORMANCE BONUS PROGRAM

This is an advisory notification to Molina Healthcare of California (MHC) network providers of updates to the Medi-Cal Pay-For-Performance/HEDIS® Performance Bonus Program (P4P Program).

**General Information:**

- Program effective: January 1, 2023.
- MHC will continue to issue HEDIS P4P payments following bi-annual schedule.
- MHC will continue including the submission of Pregnancy Notification Form incentive to this program.
- MHC will continue to offer additional incentive opportunities to the highest performing providers of each county in select measures.

**Reminders:**

- Federally Qualified Health Centers and Rural Health Centers are not eligible for this program. Please reach out to your Practice Transformation Specialist for details and how to participate in Molina's FQHC Partner Award Program.
- PCP must have at least 200 Medi-Cal members assigned at the close of the measurement period to qualify for: Cervical Cancer screening and A1c Control performance bonus.
- It is the responsibility of the participating Provider to notify MHC of any changes to their P4P enrollment forms including but not limited to name, address or W9 changes.
