This is an advisory notification to Molina Healthcare of California (Molina) network providers regarding transportation for members residing in Skilled Nursing Facilities (SNF).

The Department of Health Care Services (DHCS) continues to receive concerns from members, providers, and advocates on transportation issues.

There are members in SNFs who rely on transportation services to get to their dialysis appointments; however, the transportation appointments are either cancelled, late, or not of the appropriate mode.
